If English is not your first language you will need to complete a Secure English Language Test at IELTS 6.0 or equivalent. You may be required to attend an interview and/or provide a portfolio of work.

Any mature students who do not possess the required UCAS credits, but have a minimum of 2 years relevant industry experience together
with a portfolio of creative work (photography, animation, production design or similar) may be considered, following completion of a
diagnostic assessment and an interview.
