# JOB PURPOSE:

- Contribute to the development of strategies and policies for Knowledge Exchange, Commercialisation and Regional Economic Development.
- Support and develop all areas of activity for the Backstage Innovation Centre, including technology development, licensing, business incubation, spinout company formation, venture funding and development funding.
- Suggest new and innovative ways of delivering services that provide high quality and good value for money.
- To ensure compliance with funding requirements, project management standards and take appropriate action to address issues that may arise.
- Establish networks internally and externally relevant to the role; building and maintaining relationships with external bodies such as Arts Council England, UK Research and Innovation (UKRI), Wakefield Council, The Northern Powerhouse, the European Regional Development Fund and key industrial partners.
